On July 1, 2008, the Gallatin Solid Waste Management District (GSWMD) implemented a Late Fee Disposal Charge for commercial and private haulers that are on-site after the Logan Landfill and the Bozeman Convenience Site posted closure times. On October 27, 2010, the GSWMD amended the July 1, 2008, policy, effective December 1, 2010. On January 28, 2014, the GSWMD amended the December 1, 2010, policy, effective February 1, 2015. This policy replaces the previous Late Fee Policies.

Onsite customers unloading after the closure times will be charged a late fee in addition to their regular disposal fee. The fee is the same for all customers whether they are commercial, private, or the general public.

Winter Schedule:

Logan Landfill: November 1st through April 30th 7:30 a.m. – 4:30 p.m. Monday – Saturday; Closed Sundays

The Logan Landfill will promptly close at 4:30 p.m. At 4:31 p.m. late customers will be turned away. All customers will be required to stop unloading and leave the premises at 5:00 p.m. no exceptions.

Bozeman Convenience Site: November 1st through March 31st 8:00 a.m. - 3:30 p.m. Thursday-Saturday; Closed Sunday - Wednesday.

The BCS will close promptly at 3:30 p.m. At 3:31 p.m. late customers will be turned away. All customers will be required to stop unloading and leave the premises at 4:00 p.m. no exceptions.

Logan Landfill: May 1st through October 31st 7:00 a.m. - 5:00 p.m. Monday - Friday; Saturday 7:30 a.m. - 4:30 p.m.; Closed Sunday

The Logan Landfill will promptly close at 5:00 p.m. Monday through Friday. Saturday the landfill will promptly close at 4:30 p.m. The Saturday Late Fee will be the same as the Winter Late Fee starting at 4:31 p.m. Monday through Friday, at 5:01 p.m. late customers will be turned away. All customers will be required to stop unloading and leave the premises at 5:30 p.m. no exceptions.

Bozeman Convenience Site: April 1st through October 31st 8:00 a.m. - 3:30 p.m. Tuesday - Saturday; Closed Sunday - Monday

The Bozeman Convenience Site will close promptly at 3:30 p.m. The BCS hours will remain the same as the Winter hours 8:00 a.m. -3:30 p.m. At 3:31 p.m. late customers will be turned away. All customers will be required to stop unloading and leave the premises at 4:00 p.m. no exceptions.
